Well, the ideal scenario for Nifty500 that we had been plotting for last two weeks went for a toss this week. While we expected Nifty500 to take support of recently turned green 50EMA, it had other plans. Result - profits vanished in a jiffy! The environment in the previous week wasn't unfavorable for trading; in fact, it presented good opportunities for swing trades. Traders who went in with 100% deployment initially saw promising setups, and many performed well. However, the market lacked sustained support, following hawkish comments from the US Fed that it may slow down its interest rate cuts in 2025, causing gains to evaporate quickly.

The scenario now is such that our market has turned into a *unstable trading environment*. The risks outweigh potential rewards, making it prudent for swing traders to step aside for some time. Nifty500 will be testing its 200EMA, the zone from where it bounced back last time. Nifty50 has already closed below its 200EMA, while Sensex is sitting on it.



The % of stocks above key EMAs fell sharply and they are yet to reach the oversold zone. Think about it - we saw some intense selling pressure this week, and we're not even close to oversold zone. (For reference: we consider the market to be in the oversold zone when all three key EMAs touch the green line at the bottom.)

Nifty500's 10EMA is just marginally above 20EMA. It will cross below it on Monday (23rd December), triggering the Curtain signal.









Results Impact on Price


This week, one of our happy members messaged in our Pro-Setups community that **Blockbuster results filter** has been giving him super trades. So, we thought why not check how these companies have done since results!

Our Pro-Setups Dashboard has a filter that measures the immediate impact of earnings release on the price.

Compare the returns across classifications. Under 'Blockbuster & Positive impact', many stocks gained 25%-50%, with some exceeding that, while returns in 'Dismal & Negative impact' were negligible. Even for 0%-25% gains, 'Blockbuster & Positive impact' significantly outperformed. Additionally, very few stocks in this category had negative returns, unlike the large number in 'Dismal & Negative impact'.





Results Impact on Price


With so many results getting announced during the earnings season, it makes life of a trader really hard to concentrate on winning stocks. Pro-Setups makes your life easier by classifying earnings impact based on how stocks react to earnings.

Stock prices typically rise when a company reports good earnings and fall when it reports poor earnings.

However, it's not always clear whether the results are good or bad. Sometimes, seemingly bad results can be rewarded by the stock market, while seemingly good results can be punished if they don't meet expectations.

Ultimately, it is the stock price reaction that reveals whether the results are perceived as positive or negative by the market.

To assess the immediate price action after earnings reports, we have **Results' Impact on Price** filter in our Dashboard. This filter indicates whether the stock experienced a blockbuster, positive, negative, dismal, or no impact immediately after the results announcement.



We compare the price one day before the results with the price one day after.



Mobikwik is an Indian fintech company operating in digital financial services and digital payments. It operates a two-sided payments network consisting of consumers and merchants.


The company has two main business segments: Payments and Financial Services. The revenue contribution of these segments has shifted in recent years, with financial services becoming increasingly important.


